- **PROTECT PRIVACY:** SAFEGUARD CUSTOMER DATA AND RESPECT CONFIDENTIALITY.
- **EMBODY INTEGRITY:** CONDUCT BUSINESS IN A MANNER THAT REFLECTS WELL ON THE COMMUNITY AND INDUSTRY.
