THE BBB SYRACUSE ACTS AS A NEUTRAL INTERMEDIARY THAT HELPS RESOLVE DISPUTES BETWEEN CONSUMERS AND BUSINESSES, ENHANCES TRANSPARENCY, AND PROMOTES FAIR BUSINESS PRACTICES.

ESTABLISHED AS PART OF THE LARGER BBB NETWORK, THE SYRACUSE BRANCH ADHERES TO THE ORGANIZATION'S CORE VALUES, INCLUDING HONESTY, INTEGRITY, AND ACCOUNTABILITY. IT WORKS CLOSELY WITH LOCAL BUSINESSES, CONSUMERS, AND REGULATORY AGENCIES TO MAINTAIN A HEALTHY COMMERCIAL ENVIRONMENT.

ACCREDITATION AND RATING SYSTEM

- UPHOLDING ETHICAL BUSINESS PRACTICES CONSISTENTLY
- PROTECTING CONSUMER PRIVACY AND DATA SECURITY

RATING SCALE AND FACTORS

THE BBB SYRACUSE ASSIGNS LETTER GRADES RANGING FROM A+ TO F BASED ON VARIOUS PERFORMANCE INDICATORS. THESE INCLUDE COMPLAINT VOLUME AND SEVERITY, TIME IN BUSINESS, TRANSPARENCY, AND ADHERENCE TO BBB STANDARDS. A HIGHER RATING REFLECTS A STRONGER COMMITMENT TO CUSTOMER SERVICE AND ETHICAL CONDUCT.

CONSUMER COMPLAINT RESOLUTION PROCESS

THE BETTER BUSINESS BUREAU SYRACUSE PROVIDES A STRUCTURED PROCESS TO ADDRESS AND RESOLVE CONSUMER COMPLAINTS EFFECTIVELY. THIS SERVICE HELPS MAINTAIN TRUST IN THE MARKETPLACE AND ENCOURAGES BUSINESSES TO UPHOLD HIGH STANDARDS.

FILING A COMPLAINT

UPON RECEIVING A COMPLAINT, THE BBB SYRACUSE REVIEWS THE DETAILS AND CONTACTS THE BUSINESS TO SEEK A RESPONSE. THE ORGANIZATION FACILITATES COMMUNICATION BETWEEN BOTH PARTIES TO MEDIATE A FAIR RESOLUTION.

OUTCOMES AND FOLLOW-UP

DEPENDING ON THE CASE, THE COMPLAINT MAY BE RESOLVED THROUGH AGREEMENT, OR FURTHER ACTION MAY BE RECOMMENDED. THE BBB ALSO TRACKS COMPLAINT PATTERNS, WHICH CAN INFLUENCE A BUSINESS'S RATING AND ACCREDITATION STATUS.
