UNITED NATIONS CONVENTION ON THE LAW OF THE SEA (UNCLOS)

UNCLOS IS THE PRINCIPAL INTERNATIONAL AGREEMENT THAT CODIFIES THE RIGHTS AND RESPONSIBILITIES OF NATIONS REGARDING THE USE OF THE WORLD'S OCEANS. IT ADDRESSES NAVIGATION RIGHTS, RESOURCE MANAGEMENT, AND THE PREVENTION OF MARITIME DISPUTES. FOR BEYOND THE SEA LAW AND ORDER, UNCLOS PROVIDES GUIDELINES ON COMBATING PIRACY, ILLICIT TRAFFICKING, AND UNAUTHORIZED FISHING, EMPOWERING STATES TO TAKE ENFORCEMENT ACTIONS UNDER SPECIFIC CIRCUMSTANCES.

JURISDICTIONAL ZONES AND THEIR IMPLICATIONS

BEYOND THESE ZONES LIE THE HIGH SEAS, GOVERNED BY INTERNATIONAL LAW WHERE ENFORCEMENT RELIES ON COOPERATIVE MECHANISMS AND MULTILATERAL AGREEMENTS.

ENFORCEMENT MECHANISMS AND CHALLENGES
