LOANS

Work-Study Programs

THE FEDERAL WORK-STUDY PROGRAM OFFERS STUDENTS PART-TIME EMPLOYMENT OPPORTUNITIES ON OR OFF CAMPUS, HELPING THEM EARN MONEY TO CONTRIBUTE TOWARD EDUCATIONAL EXPENSES WHILE GAINING VALUABLE WORK EXPERIENCE.

APPLICATION PROCESS FOR FINANCIAL AID

THESE SCHOLARSHIPS RECOGNIZE STUDENTS' ACADEMIC ACHIEVEMENTS, STANDARDIZED TEST SCORES, OR SPECIAL TALENTS. THEY OFTEN REQUIRE MAINTAINING A CERTAIN GPA FOR RENEWAL.

NEED-BASED GRANTS

PARENTS OF DEPENDENT STUDENTS CAN APPLY FOR PLUS LOANS TO HELP COVER REMAINING EDUCATIONAL COSTS. THESE LOANS REQUIRE A CREDIT CHECK AND HAVE HIGHER INTEREST RATES THAN OTHER FEDERAL LOANS.

REPAYMENT PLANS

BETHUNE-COOKMAN ENCOURAGES BORROWERS TO EXPLORE VARIOUS REPAYMENT OPTIONS SUCH AS INCOME-DRIVEN REPAYMENT, GRADUATED REPAYMENT, AND CONSOLIDATION TO MANAGE LOAN PAYMENTS EFFECTIVELY AFTER GRADUATION.

WORK-STUDY AND EMPLOYMENT OPPORTUNITIES

- BORROW LOANS CAUTIOUSLY AND UNDERSTAND REPAYMENT OBLIGATIONS FULLY BEFORE ACCEPTING.
