SELECTION PROCESS

THE SELECTION PROCESS USUALLY INCLUDES MULTIPLE STAGES SUCH AS:

- ONLINE APPLICATION AND RESUME SCREENING
- APTITUDE AND TECHNICAL ASSESSMENTS
- BEHAVIORAL AND TECHNICAL INTERVIEWS
- GROUP EXERCISES OR CASE STUDIES

TAX INTERN

TAX INTERNS SUPPORT TAX COMPLIANCE AND PLANNING ACTIVITIES BY PREPARING TAX RETURNS, CONDUCTING RESEARCH ON TAX LAWS, AND ASSISTING WITH CLIENT CONSULTATIONS. THEY GAIN INSIGHT INTO CORPORATE AND INDIVIDUAL TAX ISSUES.

CONSULTING INTERN

- **DEMONSTRATE ADAPTABILITY:** BE OPEN TO NEW CHALLENGES AND FLEXIBLE IN HANDLING DIFFERENT ASSIGNMENTS.
