# Preemptive and Competitive Bidding

These are slam bidding tools that ask for the number of Aces and sometimes Kings held by the partnership:

- **Blackwood:** Typically initiated by bidding 4 No Trump.
- **Gerber:** Initiated by 4 Clubs, often after a No Trump opening.

These conventions help assess slam potential by quantifying key cards essential for high-level contracts.
