PURPOSE OF THE MEDICAL EXAM

TYPICAL COSTS OF THE I-693 MEDICAL EXAM

LABORATORY TESTS

TESTS TYPICALLY INCLUDE BLOOD TESTS FOR SYPHILIS AND OTHER INFECTIONS, AS WELL AS A CHEST X-RAY FOR TUBERCULOSIS SCREENING IF WARRANTED. THESE TESTS ARE CRITICAL TO CONFIRM THE ABSENCE OF COMMUNICABLE DISEASES.

FINDING AUTHORIZED PHYSICIANS FOR THE I-693 EXAM

ONLY USCIS-DESIGNATED CIVIL SURGEONS OR PANEL PHYSICIANS CAN PERFORM THE I-693 MEDICAL EXAM AND COMPLETE THE FORM.

LOCATING A CIVIL SURGEON

CHOOSING THE RIGHT PROVIDER

WHEN SELECTING A CIVIL SURGEON, CONSIDER THE FOLLOWING:

- LOCATION CONVENIENCE AND OFFICE HOURS
- COST TRANSPARENCY AND ACCEPTED PAYMENT METHODS
- EXPERIENCE WITH IMMIGRATION MEDICAL EXAMS
- AVAILABILITY OF REQUIRED VACCINATIONS ON-SITE

INSURANCE AND PAYMENT OPTIONS FOR THE I-693 EXAM

PAYMENT METHODS AND INSURANCE COVERAGE VARY WIDELY FOR THE I-693 MEDICAL EXAM.

INSURANCE ACCEPTANCE
