ELIGIBILITY CATEGORY

THE WORKSHEET PROVIDES A DETAILED LIST OF ELIGIBILITY CATEGORIES RECOGNIZED BY USCIS, EXPLAINING EACH CATEGORY'S SPECIFIC REQUIREMENTS. APPLICANTS WHO HAVE PREVIOUSLY BEEN GRANTED EMPLOYMENT AUTHORIZATION MUST PROVIDE INFORMATION ABOUT PRIOR EAD CARDS, INCLUDING THE DATES OF VALIDITY AND CARD NUMBERS. THE WORKSHEET PROMPTS FOR THESE DETAILS TO ENSURE THE OFFICIAL FORM IS COMPLETED ACCURATELY, FACILITATING VERIFICATION BY USCIS.

KEY SECTIONS AND INFORMATION REQUIRED

ACCURATE MAILING AND PHYSICAL ADDRESS INFORMATION IS ESSENTIAL TO ENSURE THAT ALL CORRESPONDENCE AND THE EMPLOYMENT AUTHORIZATION DOCUMENT (EAD) REACH THE APPLICANT. THE WORKSHEET ENCOURAGES DOUBLE-CHECKING THESE DETAILS.

ELIGIBILITY CATEGORY SELECTION

ONE OF THE MOST CRUCIAL PARTS OF THE WORKSHEET IS SELECTING THE CORRECT ELIGIBILITY CATEGORY. THE WORKSHEET EXAMPLE OFTEN INCLUDES A COMPREHENSIVE LIST OF CODES AND EXPLANATIONS, AIDING APPLICANTS IN MAKING AN INFORMED

COMMON MISTAKES TO AVOID WHEN USING THE WORKSHEET

INCONSISTENT PERSONAL INFORMATION

DISCREPANCIES BETWEEN THE INFORMATION ON THE WORKSHEET AND OTHER IMMIGRATION DOCUMENTS CAN CAUSE PROCESSING ISSUES. THE WORKSHEET ENCOURAGES CROSS-CHECKING DETAILS SUCH AS NAMES, DATES, AND NUMBERS TO MAINTAIN CONSISTENCY.

MISSING SUPPORTING DOCUMENTS

FAILING TO INCLUDE REQUIRED EVIDENCE OR SUBMITTING INCOMPLETE DOCUMENTATION CAN RESULT IN DELAYS OR DENIALS. THE WORKSHEET HIGHLIGHTS THE IMPORTANCE OF GATHERING AND ATTACHING ALL NECESSARY SUPPORTING DOCUMENTS BEFORE FILING.

UNSIGNED OR INCOMPLETE FORMS

OMITTING A SIGNATURE OR LEAVING SECTIONS BLANK CAN LEAD TO APPLICATION REJECTION. THE WORKSHEET REMINDS APPLICANTS TO REVIEW THE ENTIRE FORM THOROUGHLY AND ENSURE ALL FIELDS ARE COMPLETED AND SIGNED.

SUPPORTING DOCUMENTS AND ELIGIBILITY CATEGORIES

- TWO PASSPORT-STYLE PHOTOS MEETING USCIS SPECIFICATIONS

ELIGIBILITY CATEGORIES EXAMPLES

SOME COMMON ELIGIBILITY CATEGORIES INCLUDE:

- (c)(3)(C): F-1 STUDENTS APPLYING FOR OPTIONAL PRACTICAL TRAINING (OPT)
- (c)(8): ASYLEES OR ASYLUM APPLICANTS
- (c)(9): ADJUSTMENT OF STATUS APPLICANTS (PENDING GREEN CARD)
- (c)(33): DEFERRED ACTION FOR CHILDHOOD ARRIVALS (DACA) RECIPIENTS

FILING TIPS FOR A SUCCESSFUL I-765 APPLICATION

PROPERLY FILING FORM I-765 WITH THE ASSISTANCE OF A WORKSHEET EXAMPLE INVOLVES SEVERAL BEST PRACTICES THAT APPLICANTS SHOULD OBSERVE TO FACILITATE SMOOTH PROCESSING.

REVIEW AND ACCURACY

KEEP COPIES

RETAIN COPIES OF THE COMPLETED WORKSHEET, FORM I-765, AND ALL SUPPORTING DOCUMENTS FOR PERSONAL RECORDS AND FUTURE REFERENCE.
