CORE PRINCIPLES OF MEDICINES ETHICS

THE FOUNDATION OF MEDICINES ETHICS AND PRACTICE RESTS ON SEVERAL CORE PRINCIPLES DESIGNED TO ENSURE ETHICAL MEDICAL INTERVENTIONS AND PATIENT CARE. THESE PRINCIPLES PROVIDE A MORAL COMPASS FOR HEALTHCARE PROFESSIONALS WHEN MAKING DECISIONS THAT AFFECT PATIENT HEALTH AND SOCIETAL WELFARE.

BENEFICENCE AND NON-MALEFICENCE

Beneficence involves acting in the best interest of the patient by promoting good and preventing harm. Non-maleficence complements this principle by emphasizing the obligation to avoid causing harm. Together, these principles require practitioners to carefully weigh the benefits and risks of any medicinal intervention.

JUSTICE IN HEALTHCARE

JUSTICE MANDATES FAIRNESS IN THE DISTRIBUTION OF HEALTHCARE RESOURCES AND TREATMENTS. WITHIN MEDICINES ETHICS AND PRACTICE, THIS PRINCIPLE GUIDES EQUITABLE ACCESS TO MEDICATIONS, ENSURING THAT ALL PATIENTS RECEIVE APPROPRIATE CARE REGARDLESS OF SOCIOECONOMIC STATUS OR BACKGROUND.

RESPECT FOR AUTONOMY

RESPECTING PATIENT AUTONOMY MEANS ACKNOWLEDGING THE RIGHT OF INDIVIDUALS TO MAKE INFORMED DECISIONS ABOUT THEIR OWN HEALTH. MEDICINES ETHICS AND PRACTICE PRIORITIZE TRANSPARENT COMMUNICATION AND INFORMED CONSENT TO EMPOWER PATIENTS IN THEIR TREATMENT CHOICES.

ETHICAL CHALLENGES IN CLINICAL PRACTICE

BALANCING RISKS AND BENEFITS

MANAGING CONFLICTS OF INTEREST

REGULATORY FRAMEWORKS AND STANDARDS
