These ideologies were rooted in Lao culture, which prized its traditional monarchy, Buddhist faith, French learning, and nationalist conception of a Lao race. Against histories that have dismissed Lao elites as instruments of foreign powers, Wolfson-Ford shows that the RLG charted its own course, guided by complex motivations, rationales, and beliefs. During this time Lao enjoyed unprecedented democratic freedoms, many of which have not been seen since the government fell to communist takeover in 1975. By recentring the Lao in their own history, Wolfson-Ford restores our understanding of this robust but often forgotten liberal democracy, recovers lost voices, and broadens our understanding of postcolonial and Cold War Southeast Asia as a whole.
