THE DEMOCRATIC PARTY IN OKLAHOMA

HISTORICALLY, THE DEMOCRATIC PARTY HELD SUBSTANTIAL POWER IN OKLAHOMA, ESPECIALLY DURING THE MID-20TH CENTURY. MINOR AND THIRD PARTIES

BESIDES THE TWO MAJOR PARTIES, OKLAHOMA HOSTS SEVERAL MINOR AND THIRD PARTIES THAT CONTRIBUTE TO THE STATE'S POLITICAL DIVERSITY. THESE PARTIES OFTEN FOCUS ON SPECIFIC ISSUES OR IDEOLOGICAL PERSPECTIVES AND OCCASIONALLY INFLUENCE ELECTION OUTCOMES OR POLICY DISCUSSIONS.

LIBERTARIAN PARTY

THE LIBERTARIAN PARTY IN OKLAHOMA PROMOTES INDIVIDUAL LIBERTY, LIMITED GOVERNMENT, FREE-MARKET ECONOMICS, AND NON-INTERVENTIONIST FOREIGN POLICIES. WHILE IT HAS NOT SECURED MAJOR ELECTED OFFICES, THE PARTY HAS A GROWING BASE AND PARTICIPATES ACTIVELY IN STATE AND LOCAL ELECTIONS.

GREEN PARTY

THE OKLAHOMA GREEN PARTY ADVOCATES FOR ENVIRONMENTAL SUSTAINABILITY, SOCIAL JUSTICE, AND GRASSROOTS DEMOCRACY. ITS PLATFORM EMPHASIZES ECOLOGICAL RESPONSIBILITY AND PROGRESSIVE SOCIAL POLICIES. THOUGH SMALL IN MEMBERSHIP, THE PARTY CONTRIBUTES TO RAISING AWARENESS ON ENVIRONMENTAL AND SOCIAL ISSUES.

OTHER POLITICAL PARTIES

- CONSTITUTION PARTY – EMPHASIZING STRICT ADHERENCE TO THE U.S. CONSTITUTION AND CONSERVATIVE PRINCIPLES.
