## New Progressive Party (Partido Nuevo Progresista - PNP)

THE NEW PROGRESSIVE PARTY, OR PNP, ADVOCATES FOR PUERTO RICO TO BECOME THE 5 1ST STATE OF THE UNITED STATES. FOUNDED IN 1967, THE PNP PROMOTES STATEHOOD AS A MEANS TO GAIN FULL REPRESENTATION IN THE U.S. CONGRESS AND ACCESS TO FEDERAL BENEFITS. THE PARTY'S PLATFORM EMPHASIZES ECONOMIC DEVELOPMENT, MODERNIZATION, AND INTEGRATION WITH THE UNITED STATES. IT HAS BEEN ONE OF THE TWO DOMINANT PARTIES IN PUERTO RICAN POLITICS FOR DECADES, OFTEN ALTERNATING IN POWER WITH THE POPULAR DEMOCRATIC PARTY.

# POPULAR DEMOCRATIC PARTY (PARTIDO POPULAR DEMOCR? TICO - PPD)

THE POPULAR DEMOCRATIC PARTY SUPPORTS MAINTAINING PUERTO RICO'S CURRENT STATUS AS A COMMONWEALTH WITH ENHANCED AUTONOMY. ESTABLISHED IN 1938, THE PPD FOCUSES ON PRESERVING THE ISLAND'S CULTURAL IDENTITY WHILE ADVOCATING FOR ECONOMIC DEVELOPMENT WITHIN THE EXISTING POLITICAL FRAMEWORK. THE PARTY GENERALLY OPPOSES STATEHOOD AND INDEPENDENCE BUT SUPPORTS INCREASED SELF-GOVERNMENT AND PROTECTION OF LOCAL TRADITIONS. THE PPD HAS HISTORICALLY BEEN INFLUENTIAL IN SHAPING PUERTO RICO'S POLITICAL AND SOCIAL POLICIES.

## PIP)

The Puerto Rican Independence Party is the primary advocate for full independence from the United States. Founded in 1946, the PIP argues for complete sovereignty and self-determination for Puerto Rico. Although it has a smaller voter base compared to the PNP and PPD, it remains an important voice in debates over the island's political status and national identity. The party promotes cultural pride, social justice, and economic policies aligned with an independent Puerto Rico.

### POLITICAL IDEOLOGIES AND STATUS PREFERENCES

POLITICAL PARTIES IN PUERTO RICO ARE DEEPLY INTERTWINED WITH THE ISLAND'S ONGOING DEBATE OVER ITS POLITICAL STATUS, WHICH SIGNIFICANTLY SHAPES THEIR PLATFORMS AND VOTER SUPPORT.

#### STATEHOOD ADVOCACY

Parties advocating for statehood emphasize equal rights and representation for Puerto Ricans as U.S. citizens. The New Progressive Party is the most prominent proponent of this ideology.

#### COMMONWEALTH STATUS

Supporters of the commonwealth status seek to maintain and enhance Puerto Rico's current relationship with the United States. This includes retaining U.S. citizenship and federal benefits while preserving local autonomy and cultural identity. The Popular Democratic Party Champions this position, promoting a balance between self-governance and association with the U.S.

#### INDEPENDENCE MOVEMENT

THE INDEPENDENCE MOVEMENT CALLS FOR THE COMPLETE POLITICAL AND ECONOMIC SEPARATION OF PUERTO RICO FROM THE UNITED STATES. ADVOCATES EMPHASIZE NATIONAL SOVEREIGNTY, CULTURAL PRESERVATION, AND THE ABILITY TO PURSUE INDEPENDENT FOREIGN AND DOMESTIC POLICIES. THE PUERTO RICAN INDEPENDENCE PARTY STANDS AT THE FOREFRONT OF THIS IDEOLOGY, ALTHOUGH IT REMAINS A MINORITY POSITION IN ELECTORAL POLITICS.

# MOVIMIENTO VICTORIA CIUDADANA (MVC)

FOUNDED RECENTLY, THE CITIZEN'S VICTORY MOVEMENT SEEKS TO TRANSCEND TRADITIONAL STATUS DEBATES BY FOCUSING ON TRANSPARENCY, ANTI-CORRUPTION, AND PROGRESSIVE SOCIAL POLICIES. IT HAS GAINED TRACTION AMONG YOUNGER VOTERS AND THOSE DISILLUSIONED WITH THE ESTABLISHED PARTIES.

#### OTHER MINOR PARTIES

ADDITIONAL PARTIES INCLUDE THE PUERTO RICAN SOCIALIST PARTY, THE CHRISTIAN DEMOCRATIC PARTY, AND VARIOUS LOCAL MOVEMENTS. THOUGH THEY TYPICALLY HAVE LIMITED ELECTORAL SUCCESS, THESE GROUPS INFLUENCE PUBLIC DISCOURSE AND POLICY DEBATES.

## ELECTORAL SYSTEM AND PARTY INFLUENCE
